Information for applicants (Bus Driver/Operator)

A Bus Driver with Youngs Bus Service

- · Drives buses along specified routes according to a timetable.
- · Collects, checks ticket.
- Accounts for fare takings.
- Drives buses for Charter, Route and School services.
- Writes and submit reports to manager.
- Ensures safe driving practises and comfort of passengers.
- Conducts pre departure vehicle check.
- Ensures that vehicles and other equipment are treated with due care.

Alcohol, Drugs and Driving

- Under the Queensland Transport Traffic Acts, Bus drivers must register a zero drug and alcohol level at all times while driving.
- Youngs Bus Service requires all employees during working hours or at any time whilst in charge of a company vehicles or equipment to comply with this provision.

Fatigue Management

- Youngs Bus Service and its drivers have a responsibility under the Transport Operations (Road Use Management – Fatigue Management) Regulation 2008 as a condition of your employment that at all times you ensure compliance to this legislation.
- Youngs Bus Service shall assist you by providing you with access to the legislation to assist you in meeting your requirements. Whilst Youngs Bus Service shall assist and fulfil our responsibilities, you are accountable for your own responsibilities.

Training

- Before Youngs Bus Drivers commence driving with us, you will receive Induction training which covers all aspects of our business, reporting requirements, policies and procedures. Involves polishing your driving skills to meet Youngs Bus Service driving standards.
- All drivers will be given the opportunity to enter a traineeship Transport & Distribution (Road Transport) Certificate 3 which is equivalent to a trade certificate. This Certificate recognises the skills needed to be a competent driver.
- · In addition, drivers have access to regular training updates throughout the year.
- Newsletters and Memos are used to convey information about changes in legislation, road laws etc, to assist staff in remaining up to date.

Are you eligible to apply?

- · You must be a citizen or permanent resident of Australia.
- You must hold a current open Queensland Drivers License with at least an "MR" endorsement. The higher HR, HC and MC are acceptable.
- · You must have a good driving history.
- The Transport Operations (Passenger Transport) Act 1994 requires all drivers of public passenger services in Queensland to hold driver authorisation.
- Drivers must be of a physical stature to be able to sit safely in the driver's seat and safely
 maintain control of the bus. This being: can you turn the steering wheel without physical
 restriction: can you reach the pedals without straining and can you sit in a safe driving
 position.

- · Complete and sign the employment application form.
- · Attach a copy of Queensland Drivers Authorisation.
- Attach a copy of Queensland Drivers License.
- · Attach a copy of any other relevant documents eg driving history.
